MUNICIPAL TAXATION

The municipal taxation process was completed last week. All of our residents' tax bills have been mailed. If you prefer to receive a copy by email, whether because you are outside the country or simply prefer fonctioning in email, we invite you to send your request to <u>comptabilite@lac-des-seize-iles.com</u> and we will be glad to send you a copy as soon as possible.

COLLECTION CALENDAR

The collection schedule was included with your tax bill mailing. The schedule is also on our website and copies are available at our offices.

DOCK RENTALS

We would like to remind you of certain articles of the Regulation concerning the management of municipal marinas and bodies of water in our territory:

ARTICLE 25

When making a first request, citizens wishing to rent a dock space must, before March 31st of the current year, complete and send the municipal dock rental request form. The said form has been included with this newsletter for your convenience. However, you can also find it on our website.

With your application, a document specifying the registration of the boat in your name, issued by Transport Canada must be included. If you own more than one boat, all registrations must be included, and it is important to enter the dimensions of the largest boat. All information requested on the rental form must be completed and fees paid, otherwise the application will be rejected.

DOCK RENTALS

Once a dock rental space has been allocated, it is automatically reserved for the same citizen for next years, provided the following condition is respected: payment for the rental of a dock space must be made no later than the date of the first payment of municipal taxes, i.e. no later than February 20, 2024. Failing to do so, the dock will be declared unrented. A rental form must also be completed and sent to update all information.

ARTICLE 27

Each year, dock rental spaces are renewed or allocated according to availability and to the following criteria:

- 1. Lac-des Seize-Iles lakefront residents without road access to their built property.
- 2. Lac-des-Seize-Iles lakefront residents and non-lakefront residents with built property having an access road to get to their property.
- 3. Lac-des-Seize-Iles lakefront residents with built property and a boat shelter directly accessible by vehicle.
- 4. Lac-des-Seize-Iles residents with unbuilt property.
- 5. Lac-des-Seize-Iles taxpayers with a civic address in Montcalm or Wentworth-Nord that have a lot in Lac-des-Seize-Iles attached to their property.
- 6. Date of receipt of the rental request.
- 7. Non-residents of Lac-des-Seize-Iles after June 24 of each year.

Dock space rental confirmations will be sent to you during the month of April.
